Bar and Catering

- Bar prices have been kept static despite increasing costs.
- Negotiated with Rupert the removal of the excess fee for the Fish Pie alternative. More later.
- Cashless Bar has brought a benefit as no cash is kept on the premises. More later.

- We invariably complain about the price and quality of food when we dine out and KMC is no different.
- Catering still crops up more frequently than any other matter at KMC.
- The Board have removed the excess fee for the Fish Pie because some Treasurers were applying it to the individual diner. The Board thought that this was harsh as that dietary issue should not be penalised.
- Rupert was very accommodating and agreed to help with the removal of the fee.
- ▶ The fee for Cheese and Biscuits will remain.

- Rupert prides himself on always providing a dining alternate in every circumstance.
- People booking meals need to look more closely at the menu on the website themselves.
- Units need to be inventive in how to deliver the right dining choices and talk to Rupert.
 All the comments on the report cards (that are on the website) are excellent.
- Most complaints are about the vegetarian options.
 - ▶ How many times do you dine out and there are 4 different vegetarian choices?
 - If you don't like the chosen option, have you tried all 4?
 - Rupert has told me has tried all the vegetarian dishes. In his opinion they are very good.

- Part of recent Board changes were related to catering issues.
- ► Potential catering change would have meant KMC would have to employ a House Manager. Like Peter's role at Warwick.
 - Rupert and his staff, Denise and Mark are KMC's House Managers.
- Currently bar supplies are ordered, stocked and supplied by Denise and Mark.
- Mark was before the Cashless Bar the person doing the Banking. That's one of the reasons why I implemented the Cashless Bar.
- Rooms set up and cleared by Rupert staff
- As Denise and Mark are employed by Rupert, KMC has no staff. As KMC has no Employees, no Tax, NI, Insurance liability premiums, Regulations, training, compliance, hiring and firing etc.

- ► A House Manager would cost KMC c£35K per annum.
- ► The "House Manager" role is done by Rupert's staff for free.
- There are approximately 800 Masons meeting at KMC. That £35000 per annum would mean a £45 £50 per person per annum increase in subscriptions for every order that you are a member of that meets at KMC.
- How many Masons would we lose if everyone started paying that extra subscription?

Making the most of KMC.

- If your Unit cannot dine here because of low numbers
 - Permanent guests between similar orders?
 - ► Treasurers, please think outside of the box.
 - ► Keep Masonic money inside Freemasonry.

Financial Overview

- ► Flat Rent increase new letting agents. 20% increase
- ► Flat Utilities without my knowledge as Finance Director, they were not being paid. Now resolved.
- Income & Expenditure in balance but Province grant supporting us in that balance to varying degrees year by year
- Units returning warrants reduce income.
- Impact of bottom line saving £7.5K not fully seen in accounts yet.
- ▶ Other smaller issues. Savings on Biffa / Gas contract ...

Financial Overview - Future

- Termination of the SSE fixed price contract in 2025.
- Spending will have tighter controls.
- Projects Front door


Report of the Chairman 1
